



**LEGACY LEAGUE, INC.**  
**Standing Rules, Rev A**

1. All Legacy League members will be required to purchase an authorized Legacy League Polo Shirt. These shirts are to be worn to all Legacy League general meetings and whenever representing Legacy League in the community.
2. All service work shall be done in Legacy League Polo Shirts. Exceptions shall be at the discretion of the Service Vice-President.
3. To obtain credit for service hours, a Legacy Service Hour Sheet must be filled in with the date of the service, the description of the service provided and be signed and dated by an adult who witnessed the service. A Service hour is considered the time spent volunteering at one of the designated Legacy philanthropies. Travel time to and from the philanthropy does not qualify as time spent volunteering. Service hours cannot be awarded from contributions to the designated philanthropies. Service hours may not be signed by the Mother/Adult Sponsor of the member providing the service. Service hours will only be accepted when submitted on an official Legacy Service Hour Sheet.
4. Each member of Legacy must earn at least one committee hour each year. A committee hour may be earned by one or more of the following: help with set up and/or cleanup of the Legacy Ball, setup and/or cleanup of the Legacy Fundraiser, setup and/or cleanup of a general meeting, and volunteering to provide refreshments for general meetings. Committee hours will be recorded by the Second Vice-President, Service. A Board Member (Adult/Advisor) and/or the Committee Chairperson (Adult/Advisor) for which the committee hour is being earned may sign to verify the committee hour.
5. Two (2) no-shows at a scheduled volunteer activity, two (2) failures to get a substitute, and / or two (2) unexcused absences from a scheduled volunteer activity can be grounds for dismissal. The Second Vice-President, Service will keep track of all such activities.
6. All Legacy League members are required to complete fifteen (15) service hours.
7. It is mandatory for all provisional and active members to participate in the annual fundraiser by purchasing four (4) tickets and donating one (1) item of \$25.00 value to the silent auction.
8. It is mandatory for all provisional and active members to attend four (4) general meetings (the fundraiser is the only special meeting that counts as a general meeting) to remain a member in good standing. Special meetings such as Board, Provisional, and Senior meetings do not count towards the general meeting requirement. The annual induction of new members does not count towards the general meeting requirement.
9. To receive meeting credit, it is mandatory for all provisional and active members to sign-in at the general meetings. Mothers/Adult Sponsors may not sign in for members. Friends may not sign in for other members. Members who sign in and leave before the meeting is finished will not get credit for the meeting, unless otherwise approved by the First Vice-President.
10. Any Legacy League member who is observed behaving inappropriately at an official Legacy League function will be dismissed from Legacy League. Any Legacy League member who is under the influence of alcohol, a controlled substance, dangerous drugs, and/or marijuana in any form shall be immediately asked to leave the function and will be dismissed from Legacy League.
